Accomodation

A neatly presented one bedroom ground floor apartment, situated in an idyllic development for residents aged 55 and over, just a short walk from Thirsk's shops and amenities. Positioned in a friendly community with affordable service charges, the property is sure to appeal to those looking for a retirement home or to downsize.

The apartment is ideally located for access to the centre of Thirsk, with shops and amenities just a short walk away. Transport links are also readily available, including regular bus services and Thirsk train station close by, along with the A19 and A1 a short drive away.

Entering the property, there is a spacious open plan living space with a large window flooding the room with natural light, also enjoying a lovely outlook over the communal courtyard. The kitchen is fitted with a variety of units and some appliances, including a ceramic hob and double oven, whilst there is space for a washing machine, dishwasher and small dining table. From the living space, there is a good sized double bedroom and a shower room, which is part tiled and fitted with a white suite, including a shower cubicle and vanity basin. Handrails have also been installed, ideal for those requiring accessible living. The apartment is double glazed throughout and benefits from gas central heating. Energy bills are also community collected, each property pays £148.00 each calendar month for utilities, along with £100.00 ground rent and £924.00 service charge annually, making the apartment cost effective.

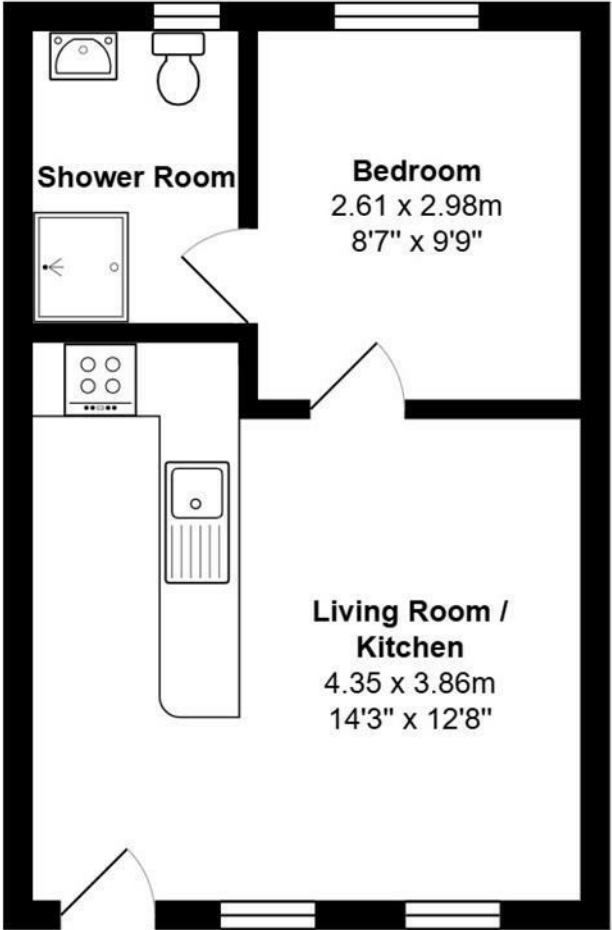

Neutrally decorated throughout with reasonable service charges, an early viewing is advised on this lovely home with a peaceful setting.



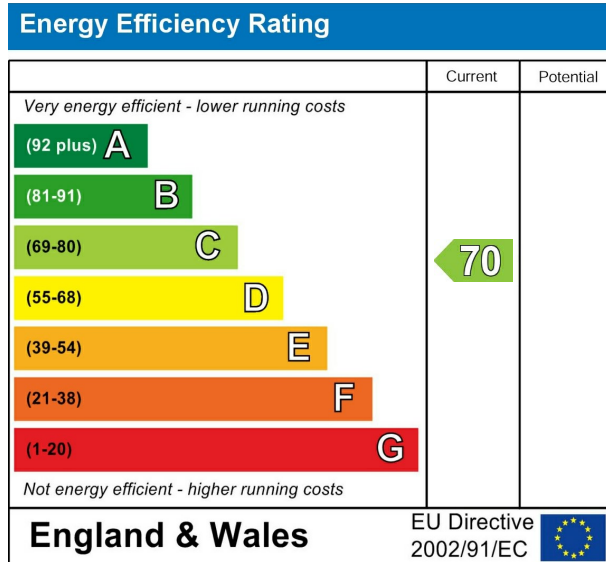


Floorplan
